S.U.C. REGULATION AND RULES

At the Snipers Unknown Challenge(SUC) competition we offer a unique style of shooting experience which usually only pertains to a unique group of military personnel or law enforcement. Expected to be challenge at each stage and enjoy the SUC!

Although safety is paramount, we do not offer information on stages prior to the event. Only information we provide you is to be prepared to engage targets with pistol or rifle. Gear is dependent on your team and are expected to be able to sustain yourself for the entirety of the day. The threats of each stages are uncertain so pack accordingly.

Prior to each day you will receive a safety and stage brief for that entire day. Its imperative you listen carefully to each daily brief as you will be expected to approach each stage ready to overcome and adapt to each stage. Failure or success is entirely on how each team processes information and communicates effectively.

Any questions you may have please feel free to ask prior to movement to the staging areas. Attention to detail is key, so take notes if need be.

WEAPON RESTRICTIONS

Rifles- No magnum rifles are allowed, and all velocities must stay under 3200 fps. In previous years we restricted one team member to 223/556, but we now want to offer teams a choice to plan each stage and utilize the tools they feel will best suit each scenario. Engagements for primary shooter will be 0-1100 and 0-600 for alternate shooter.

Pistols- No calibers over 45 ACP, and no AR-pistols are to be utilized.

Ammo- No steel core or any steel penetrator will be allowed. They cause unnecessary damage to our targets. Please check ammo prior, to coming to the competition. Any targets engaged with unauthorized ammo will be disqualified and will terminate your team from the rest of the competition. Recommendation of a minimum of 120 rounds for rifle and 100 rounds of pistol per shooter.

Optics- There are no restrictions for either rifles or pistols.

Gear- You will be working as team so plan accordingly.

ANY GEAR LEFT AT YOUR VEHICLE OR HEADQUARTERS WILL BE NOT RETRIVED AFTER THAT MORNINGS MOVEMENTS TO THE STAGES.

I understand that the presence of the Snipers Unknown Challenge and property personnel is no assurance of my safety or the lessening of any of these risks.
