This letter is in response to your Freedom of Information Act (FOIA) request dated September 6, 2022 reference number AMC FOIA # FP-22-027423/FA-22-1888. The request is for ownership history on a M24 Sniper Rifle Serial Number: C6498772.

The following Information was found in the Department of Defense (DoD) Small Arms/Light Weapons Registry for a 7.62mm M24 Sniper Weapon System, NSN: 100501-240-2136, Serial Number: C6498772. The records for this weapon are listed below in chronological order:

1. June 15, 1990 – The Remington Arms Company LLC - Ilion shipped the weapon to the Anniston Munitions Center - Anniston, Alabama.
2. June 28, 1990 – The Anniston Munitions Center - Anniston, Alabama received the weapon from the Remington Arms Company LLC - Ilion.
3. August 10, 1990 – The Anniston Munitions Center - Anniston, Alabama shipped the weapon to the Installation Supply Division - Fort Campbell, Kentucky.
4. August 12, 1990 – The Installation Supply Division - Fort Campbell, Kentucky received the weapon from the Anniston Munitions Center - Anniston, Alabama.
5. October 22, 1990 – The Installation Supply Division - Fort Campbell, Kentucky shipped the weapon to the Anniston Munitions Center - Anniston, Alabama.
6. October 25, 1990 – The Anniston Munitions Center - Anniston, Alabama received the weapon from the Installation Supply Division - Fort Campbell, Kentucky.
7. January 04, 1991 – The Anniston Munitions Center - Anniston, Alabama shipped the weapon to the U.S. Army Tank Automotive and Armaments Command (TACOM) Total Package Fielding Site - Fort Belvoir, Virginia.

8. January 20, 1991 – The TACOM Total Package Fielding Site - Fort Belvoir, Virginia received the weapon from the Anniston Munitions Center - Anniston, Alabama.
9. January 30, 1991 – The TACOM Total Package Fielding Site - Fort Belvoir, Virginia shipped the weapon to the Mission Contracting Office, United States Army Garrison (USAG) - Fort Belvoir, Virginia.
10. February 01, 1991 – The Mission Contracting Office, USAG - Fort Belvoir, Virginia received the weapon from the TACOM Total Package Fielding Site - Fort Belvoir, Virginia.
11. February 28, 1991 – Owning activity of the weapon has been reported as the United States Army Garrison (USAG) - Fort Myer, Virginia and posted to the DoD Small Arms/Light Weapons Registry.
12. May 31, 1995, March 29, 2000, June 30, 2000, September 27, 2000, November 27, 2001, March 27, 2002, March 25, 2003, March 23, 2004, February 21, 2005, February 24, 2005, March, 29, 2005, July 12, 2005, September 27, 2005 and March 28, 2006 – The USAG - Fort Myer, Virginia conducted annual weapon serial number reconciliations on the weapon.
13. May 22, 2006 – The USAG - Fort Myer, Virginia shipped the weapon to the 289th Military Police Company - Fort Myer, Virginia.
14. November 21, 2006 – The 289th Military Police Company - Fort Myer, Virginia received the weapon from the USAG - Fort Myer, Virginia.
15. October 30, 2012 – The Defense Logistics Agency (DLA) Distribution - Anniston, Alabama received the weapon from the USAG - Fort Myer, Virginia.
16. December 17, 2012 – The DLA Distribution – Anniston, Alabama shipped the weapon outside the DoD to the Remington Arms Company LLC - Madison, North Carolina.
17. March 26, 2013 – The DLA Distribution - Anniston, Alabama received the weapon from the U.S. Army Contracting Command Contracting Office - Picatinny Arsenal, New Jersey. The weapon received was an upgraded M24 Sniper Weapon System, the M2010 Enhanced Sniper Rifle (ESR), NSN 1005-01-5882913.
18. April 03, 2013 – The DLA Distribution – Anniston, Alabama shipped the weapon to the Group Service Support Company, 5th Special Forces Group - Fort Campbell, Kentucky.

19. April 04, 2013 – The Group Service Support Company, 5th Special Forces Group - Fort Campbell, Kentucky received the weapon from the DLA Distribution – Anniston, Alabama.
20. September 02, 2016 – The U.S. Army Logistics Readiness Center - Fort Campbell, Kentucky received the weapon from the B Co, 2nd BN, 5th Special Forces Group - Fort Campbell, Kentucky.
21. September 02, 2016 – The U.S. Army Logistics Readiness Center - Fort Campbell, Kentucky shipped the weapon to the Group Service Support Company, 5th Special Forces Group - Fort Campbell, Kentucky.
22. September 22, 2016 – The DLA Distribution – Anniston, Alabama received the weapon from the U.S. Army Logistics Readiness Center - Fort Campbell, Kentucky.
23. September 23, 2016 – The DLA Distribution – Anniston, Alabama conducted an annual weapon serial number reconciliation on the weapon.
24. October 13, 2016 – The DLA Distribution – Anniston, Alabama shipped the weapon outside the DoD to the Remington Arms Company LLC - Madison, North Carolina.
